Release and Waiver of Liability**

I further agree to indemnify and hold harmless and defend the Releasees from any and all claims, damages, liabilities and/or costs (including attorneys' fees) arising out of, connected with or in any way associated with my participation in the event.

This document is intended to be as broad and inclusive as permitted by law, and if any portion hereof is held invalid, it is agreed that the balance shall notwithstanding, continue in full legal force and effect. This document embodies the entire agreement with respect to these matters and supersedes any previous or contemporaneous negotiations or agreements. Each of the undersigned agrees that no promise or inducement has been offered except as herein set forth, and that this document has not been executed based upon statements or representations by any person or entity other than those set forth herein. This document shall be governed by and construed under the laws of the state of Illinois without regard to conflicts of law principles therein.

Further, I hereby grant full permission for event organizers to record any or all of my participation in this event for photos, motion pictures, TV, radio, recording, videotapes, and other media known or unknown, and to use them, no matter by whom taken, in any manner for publicity, promotions, advertising, trade or commercial purposes, without any reimbursement of any kind due to me, or the need to pay me any fee.
